- To promote social contacts among healthcare professionals of the country.
- To undertake and promote scientific and pharmaceutical research activities related to pharmaceutical and medical sciences

2. REGISTRATION & ABSTRACT SUBMISSION

- Register yourself as a Presenter for the conference of pharmacy and medicine 2025 on or before 10 January 2025 for confirming your participation: www.icpm.ae
- After you sign up in the website, click on registration and provide necessary details, when prompted click on the new conference registration', choose "Presenter' and use the complimentary code issued to you via email.
- Please indicate the POSTER CODE when you are submitting the poster.
- Abstract submission details (**Submission ID, Main Author, Email of Main Author, Co-Authors, Supervisor, Institution, Title and Abstract**)

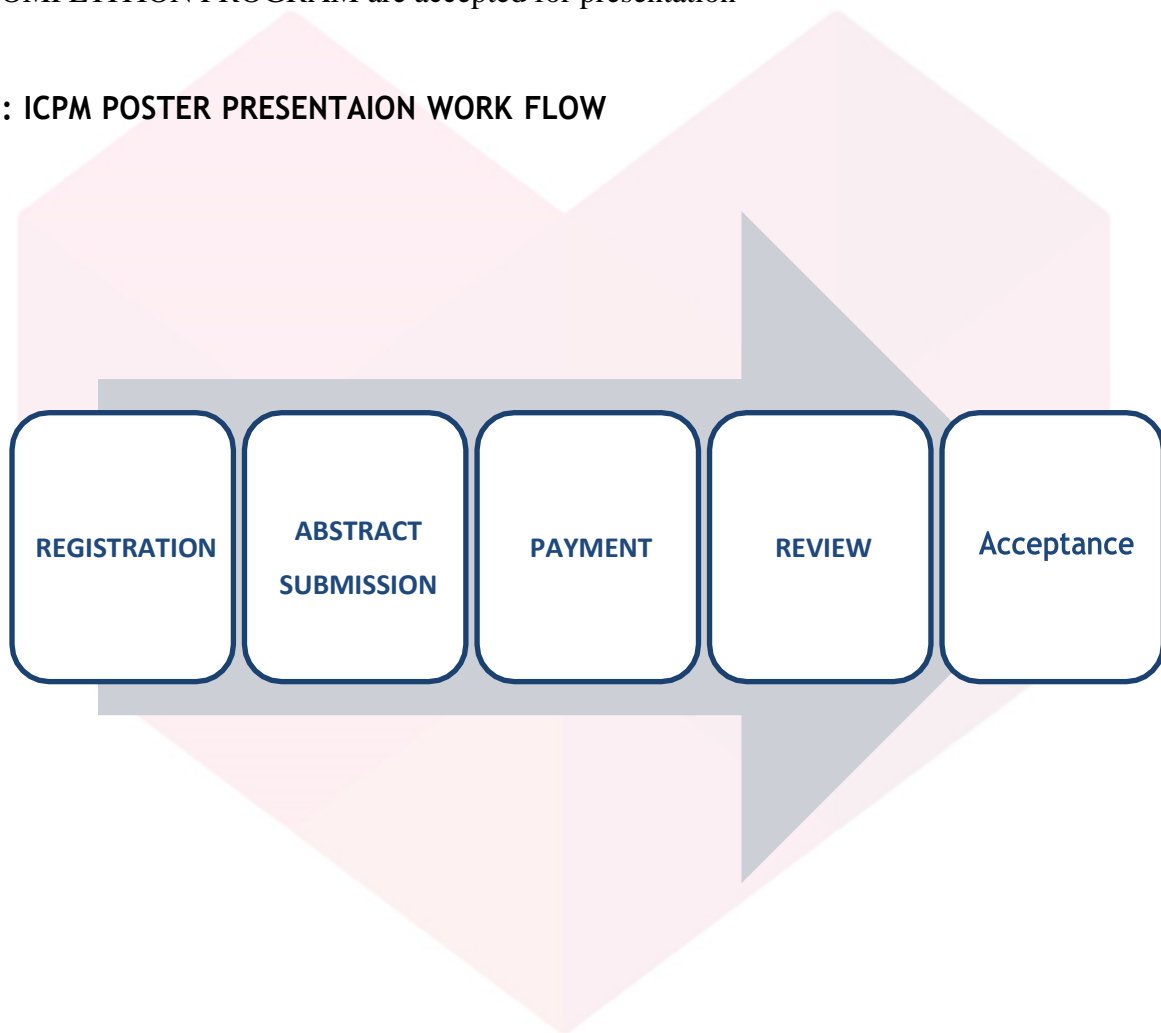
3. PAYMENT

- A fee of AED 100 is required for each poster to be paid at the time of poster submission plus 5% TAX/VAT

4. REVIEW

- On submission, the ICPM reviewers and assessors will review all submitted abstracts initially for suitability for formal review. Abstracts with insufficient originality, serious scientific or technical flaws, or lack of a significant message, if not prepared as per ICPM POSTER PRESENTATION instructions are rejected.
- Abstracts that are found suitable for presentation in ICPM POSTER PRESENTATION COMPETITION PROGRAM are accepted for presentation

5. POSTER GUIDELINES

- Title of the poster must be displayed clearly at the top of the poster and should include the names of the author(s) and the institution(s) of origin
- Information should be summarized, using brief written statements, graphic materials such as photographs, charts, graphs, and diagrams mounted on standard size poster of 100 cm x 90 cm
- Double face tape and mounting materials will be supplied at the conference site
- Authors must print and prepare all posters beforehand in a form enabling easy mounting
- Poster orientation must be portrait.
- Please use clear labels for each section of the poster. Text should be of sufficient size for easy reading at a distance of 1.5 meter (Between 16-20 font size).

6. DISPLAY AND PRESENTATION

- Author(s) is (are) responsible for mounting and taking down their poster during the conference.
- Poster presenters should be available to discuss their posters with the conference participants during the coffee breaks.

7. ABSTRACTS WITH MULTIPLE AUTHORS

- All authors must register to attend and receive the poster presentation certificate
- Names of all the Authors must be sent along with a clear photo shot of the poster before 10th January 2025 to www.icpm.ae

8. Other

- Ensure compliance with all safety measures and COVID-19 protocols.
- All posters displayed are automatically entered for the Poster Competition.
- Posters should NOT be removed before 1:00 pm on Day 3.
- The results of the Poster Competition will ONLY be ANNOUNCED during the Closing Ceremony on Day 3. Prior information of results will NOT be provided if the presenter is unable to attend the Closing Ceremony on Day 3
- Only ONE certificate will be awarded to the main author who is attending the event. No additional certificates will be awarded to co-authors.
- Certificates can only be collected on Day 3 of the event. Certificates will not be posted or available before Day 3 of the Event.
- All poster presentations accepted to present at the conference must register. NO accommodation is offered to attending oral presenters.
- In case you will not be able to attend the Conference, please inform us in writing on or before 1st January to withdraw your participation & to enable participation of Other interested candidates.
- The winning poster project will be shared with Sharjah Innovation Park along with other authorities to take care of.
